MEASURE I/Y - Resolution No. 4796, 07/2012 & Ordinance No. 677

A. Appointment: Mayor and city council shall each annually appoint one member of the public to serve as an oversight committee for the revenue that the city receives from the tax enacted by this article and to recommend the use thereof. The City Manager shall provide staff for the committee, and the Finance Director shall provide all relevant data regarding revenue from the tax and expenditure thereof.

B. Appointment: In accordance with Ordinance No. 677, which enacted the Measure Y sales tax, commencing in 2022 the Mayor and City Council shall each appoint one member of the public to serve on the City of Soledad Measure Y Citizens Oversight Committee for a two-year term. A maximum of three Committee Members currently completing a one-year appointment in 2022 shall be eligible for reappointment to a new one-year term. Committee members are eligible for reappointment by Councilmembers for a second, ~~two-year~~ term. No Committee member shall serve more than two consecutive two-year terms.

MEASURE S

A. Appointment: In accordance with Ordinance No. 734, which enacted the Measure S sales tax, the Mayor and City Council shall each annually appoint one member of the public to serve on the City of Soledad Measure S Citizens Oversight Committee for a one-year term. A maximum of three Committee members will be eligible for reappointment by Councilmembers for a second, one-year term. In the event more than three are willing to a one year reappointment, Committee members will be reappointed on the basis of the seniority of the appointing Councilmember. In addition, the Mayor shall appoint four (4) additional Committee members to one-year terms, with City Council approval, that have specialized knowledge and agree to represent the Committee in one of the following areas: (1) Senior Services, (2) Animal Services, (3) Childcare Services, and (4) a member of the Soledad Youth Council.

In addition, the Mayor shall appoint four (4) additional Committee members to one-year terms, with City Council approval, that have specialized knowledge and agree to represent the Committee in one of the following areas: (1) Senior Services, (2) Animal Services, (3) Childcare Services, and (4) a member of the Soledad Youth Council.
